

**COMMUNITY CHOICE FATHER'S DAY GIVEAWAY
OFFICIAL RULES**

NO PURCHASE OR TRANSACTION NECESSARY TO ENTER OR WIN. A PURCHASE OR TRANSACTION WILL NOT IMPROVE YOUR CHANCES OF WINNING.

This Giveaway starts at 9:00 p.m. on June 1, 2026, and ends at 5:00 p.m. on June 17, 2026. The sponsor of this Giveaway is Community Choice Credit Union, 31155 Northwestern Hwy, Suite 294, Farmington Hills, MI 48334 Community Choice Credit Union. The Giveaway shall be subject to these Official Rules, and by entering, all entrants agree to abide and be bound by the terms and conditions herein and the decisions of the Sponsor.

1) **How to enter:** You can be a member or non-member of Community Choice Credit Union to enter. Membership is subject to the Community Choice Membership Agreement, which is incorporated herein by reference. Contest entry is free of charge. All entries must be received during the applicable Entry Period. Limit one entry per person per Entry Period; duplicate entries from the same person during the same Entry Period will be disqualified. Your contact information must be accurate in order for your entry to be eligible.
